I hereby agree to indemnify and hold harmless Good Karma Petspa, its employees, directors and agents from any and all claims, or claims by any member of my family or any other person accompanying me to a function of Good Karma Petspa, or while attending the premises thereof, as a result of any action by any dog. _____
4. I hereby state that my Dog is of good health and has not been ill with any known contagious diseases within the last thirty days. _____
5. I recognize that the health of the Dog is the owner's responsibility. I hereby represent that all required vaccinations (rabies, ordatella, distemper and parvovirus) are up to date. I will also continue to ensure that the required vaccinations will be kept up to date for as long as the Dog attends Good Karma Petspa daycare. I will provide proof of all booster vaccinations to Good Karma Petspa. _____
6. I further understand and agree that in admitting the Dog, Good Karma Petspa has relied on my representation that the Dog is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other Dog. _____
7. I further understand and agree that Good Karma Petspa and their caregivers will not be liable for any problems that might develop with the Dog, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed. _____
8. I further understand and agree that any problem that develops with my Dog will be treated as deemed best by the caregivers of We Good Karma Petspa at their sole discretion and that I assume full financial responsibility for any and all expense involved. _____
9. The hours of operation of Good Karma Petspa are 6:30 a.m. to 6:30 p.m. ("Closing Time") Monday to Friday (except statutory holidays). I agree that management of Good Karma Petspa retains the right to amend the hours of operation at any time. _____
10. I agree to pick up the Dog prior to closing time. It is hereby acknowledged that that should I fail to pick up the Dog before closing time a \$10.00 late fee will be charged at 6:30pm and again at 6:45:pm (for a maximum of \$20.) to be paid in cash upon my arrival at Good Karma Petspa. _____
11. Good Karma Petspa fees are non-refundable and non-transferable. _____
12. I agree that the Dog may be videotaped, photographed and or recorded. Good Karma Petspa shall be the exclusive owner to the results and all proceeds of such media. _____
13. Good Karma Petspa reserves the right to permanently remove a Dog from its daycare at anytime, I, _____, certify that I am eighteen years of age or older and have the legal capacity to enter into a binding contract. Further I certify that I have read and understand the rules and regulations as set forth in this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions and statements of this agreement.

14. I hereby allow the staff of Good Karma Petspa to walk my dog off leash in designated off leash parks.

In the event of an emergency, Good Karma Petspa has your permission to transport your dog to the above veterinarian, or the nearest animal clinic whenever we reasonably deem it necessary. Payments arrangements are to be made between the dog owners and veterinarian.
